Bloodworks Official Rules

NO PAYMENT OR PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PAYMENT OR PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. The Bloodworks Dine & Dance on the Ice Sweepstakes ("Sweepstakes") is a promotional giveaway designed to encourage Donors to register with Bloodworks for donations and to promote Bloodworks. The Sweepstakes are sponsored by Bloodworks ("Sponsor") with the principal place of the organization located at 921 Terry Avenue, Seattle, WA 98104. Sponsor will randomly select winners as defined herein and prizes as defined herein will be awarded in accordance with these Official Rules and are provided as-is. **Angel Of The Winds Arena is neither a participant in nor a sponsor of the Sweepstakes.**

1. **Eligibility:** In order to be eligible to participate in the Sweepstakes one must agree to be bound by these Official rules which constitute a binding agreement. The Sweepstakes are open to legal residents of Washington or Oregon only who are at least eighteen (18) years or older at the time of entry ("Entrants" or "Participants"). The employees of Bloodworks ("Bloodworks") and all other companies, partners, advertising and promotion agencies associated with the design or execution of the Sweepstakes and the members of their immediate families (parents, grandparents, siblings, children, grandchildren and each of their respective spouses) and those living in the same household of each (whether related or not), are ineligible to enter. Entrants may decide to not opt in to the Sweepstakes when they register to donate. Donors may also contact Bloodworks to ensure they are not entered in the Sweepstakes automatically should they desire to not participate. For the avoidance of doubt, an Entrant may opt out of the Sweepstakes at any time and there is no obligation whatsoever to participate by any Donor. Bloodworks will immediately cancel any participation at the request of any Entrant or donor. There may be additional documents for Entrants to complete in order to be eligible to win prizes in the Sweepstakes and such will be provided and requested when applicable by Bloodworks to said Entrants with instructions on any of the aforesaid.

2. **How to enter:** To participate in the Sweepstakes, Participants who meet the eligibility requirements as noted herein, must register to donate in-person at the Bloodworks blood drive: Pop-Up @ Edward D. Hansen Conference Center located at Angel Of The Winds Arena, in Everett, Washington (defined below) during the dates of November 10, 2020 – November 19, 2020 (the "Sweepstakes Period"). Bloodworks will pull all the names of Participants within the age/time period parameters specified herein and enter them in the Sweepstakes. All Entrants, i.e., those individuals entered in the Sweepstakes, must abide by these Official Rules (the "Official Rules") to be eligible to win a "Prize" as defined below and to comply with all federal, state and local laws and regulations. Entrants who do not provide complete, valid, and truthful registration information will not be eligible to win. Once registration is completed to the satisfaction of Bloodworks, the Entrant will be entered into the Sweepstakes as per the Official Rules. Limit one entry per Entrants or Participants throughout the Sweepstakes. For the avoidance of doubt, the criteria of eligibility for the Sweepstakes is such that Entrants must only register with Bloodworks to donate and meet the Official Rules requirements noted herein. Participation in the Sweepstakes is NOT predicated on Entrants being able to actually donate with Bloodworks. Registration to donate creates eligibility as long as Entrants are eligible in the other aforesaid areas of these Official Rules. Participants may not register with multiple names, addresses (including e-mail addresses) and any Entrant who attempts to enter with multiple names, addresses (including e-mail addresses) will be disqualified and forfeits any Prize won, in Bloodworks' sole discretion. Entries in excess of the stated limits will be disqualified. Any potential "Winner", i.e., a person who wins a Prize, may be requested to provide Bloodworks with proof that such Winner is a legal resident of Washington or Oregon. Each Winner must agree to the Bloodworks use of his or her name, likeness, photograph, picture, portrait, voice, biographical information and/or any statements made by Winner regarding the Sweepstakes without additional compensation, obligation, or notice, for the purposes of publicity and promotion, worldwide and in perpetuity, in any and all forms of media, now known and hereafter devised, including, without limitation on-line.

3. **Prizes and odds of winning:** One (1) Prize Winner (only) will receive a private two-hour ice rink rental at the Everett Community Ice Rink for up to five (5) people (for the avoidance of doubt, this is up to five (5) tickets total for the Prize Winner, restrictions apply due to COVID-19 on the amount of guests at Everett Community Ice Rink during the usage of the "Prize"), the tickets can be used by the Prize Winner for any aged person, which includes skate rentals and dinner (herein "Prize"), total value of the Prize is estimated at a value of approximately: \$730.00 USD. Reservations for private ice time will need to be scheduled with the Angel Of The Winds Arena Marketing Director at the email address: Larissa.long@spectrapp.com. You may also contact Bloodworks at the contact information provided herein for assistance. Scheduling will be based on availability at the time of reservation. Reservation must be booked with no less than two weeks' notice. Dinner will be provided with limited menu options by Lombardi's Italian Restaurant for up to five (5) people. Bloodworks is not responsible for arranging transportation to or from the Prize venue. Odds and chances of winning a Prize are based upon the number of eligible entries received with all Entrants having an equal chance of winning; Winners will be selected randomly as noted below. All other costs and expenses in connection with Prize, including but not limited to, receipts and use of the Prize, are the sole responsibility of the Winner. The Prize may only be awarded upon proof of Entrants' registration with Bloodworks. The Prize is not transferable and must be accepted as awarded by Bloodworks. Bloodworks reserves the right, in its absolute and sole discretion, to make a substitution of a prize, to serve as the Prize, provided it is of equivalent kind or approximate value in the event of the unavailability of the Prize for any reason. **For the avoidance of doubt, the Prize must be redeemed with four (4) months of Winner receiving the Prize or the Prize is forfeited by the Winner.**

4. **Winner Selection and Notification:** The Sweepstakes is a giveaway of chance. The one (1) Winner of the Prize will be randomly selected from all eligible entries on or about November 23, 2020 and will be posted on Bloodworks' website at www.Bloodworksnw.org and Bloodworks' Facebook page. Two (2) additional participants will be selected as alternates also at random. "Alternative Winners", in the event the Winner randomly selected is unable to accept the Prize for any reason(s) whatsoever or declines to receive it. Bloodworks will notify the Winner by phone call or email (at Bloodworks' selection based on the registration information provided). Winners shall have forty-eight (48) hours from the time Bloodworks has placed a notification phone call and/or from the time Bloodworks has sent a notification email to respond to Bloodworks and accept their Prize with proof of identification, or, at Bloodworks' option, the next-in-line Alternative Winner will be chosen and notified and awarded the Prize.
